Thank you for your interest in Frederick Aero Club! This page outlines the requirements for Application to the club.

Requirements for Membership Application

Required Documents – Please send electronic copies to Mark Edwards at mse103@mac.com Contact Mark if you wish to submit physical copies.

- Membership Application completed in its entirety
- Copy of Drivers License
- Copy of FAA Pilot Certificate (Front and Back)
- Copy of FAA medical OR copy of BasicMed Doctors Exam certification page, and copy of online BasicMed Training Certificate
- Copy of DC SFRA Training certificate or card
- Recent Copy (in last 90 days) of State Driving Record
- Copy of current flight review (if your flight review has expired, it does not preclude you from membership, as you may obtain your flight review from a club instructor, at which time you may submit the copy of the flight review to the club secretary

Additional Requirements

- ...attend at least one monthly membership meeting to meet the club members and/or have made other arrangements to meet the members. Please see club treasurer/club officers for details.
- ...show the club treasurer/club officer a copy of your recent credit report prior to consideration for a membership vote. A credit score is not sufficient. You may meet with the club treasurer/club officer prior to a club membership vote to allow us to review it. The club does not retain a copy of any credit information in our files, and we do not require you to give us a copy of the information, just provide for our officer(s)' review.

After all above requirements are met, Frederick Aero Club will review and verify the documents. If anything is found that would preclude your membership, you will be notified. If there are no issues, the membership vote usually will occur at the next regular monthly meeting.

If your membership is approved:

- You must immediately submit the initiation fee plus first month's member dues to the club treasurer.
 - O If you are taking over an outgoing member's membership, you must immediately contact that member to make arrangement for payment of the initiation fee. You must also submit the first month's member dues to the club treasurer. The club does not prorate membership dues, so you will have the option of starting your membership immediately (paying full dues for the current month) or starting at the first of the upcoming month.
- You will be given contact information for the CFI's in the club, and must make arrangements with one of them for a check-out in the club airplane. Upon completion of your checkout, you will be enabled in the scheduling system and given keys to the airplane. You will also be added to the clubs' email list
- Monthly dues are due on the 15th of each month. For example, January dues are due no later than Jan 15th. Flight times are billed on Hobbs time. In the above example, December flight time is due no later than Jan 15th.

Requirements for Waiting List Application

- Waiting List Application completed
- Copy of Drivers License
- Copy of FAA Pilot Certificate (Front and Back)

Waiting list applicants will be added to waiting list on a first come first served basis upon receiving ALL the above items. Applicants on the waiting list will be contacted periodically (about once every 90 days) to confirm their interest in remaining on the list. If you decide to drop off the list for any reason, please contact us immediately. If contact is not established during the check-in periods, you will be removed from the waiting list.

If a membership slot becomes available:

If a slot opens up, you will be contacted via email and will be provided 14 days from the date of contact to submit a completed New Membership Application and all supporting documents. Applicants who are placed on the waiting list must attend at least one monthly membership meeting. This requirement is to prevent any delays in processing your membership packet when a slot becomes available. Failure to provide the full membership package requirements within 14 days will result in forfeiture of your position on the waiting list. You may request to be placed back on the waiting list, however your position will move to the end of the list.
